★ Strengthen objective and logical analysis ability in problem solving

- ♦ Avoid suggesting predetermined cause or countermeasure
- ♦ Logically and consistently conduct analysis
- ♦ Analyze deeper until finding true objective root cause
- ♦ Define countermeasure which can prevent problem happening again
